## Fall 2008 Executive Committee Meeting Summary

#### Fall 2008 Executive Committee Meeting Notes

October 4, 2008

Call to order at 12:30 pm. Present: Lucy Bambrey, Kristin Kuckelman, Cheryl Harrison, Mary Sullivan, Sean Larmore, Steve Dominguez.

#### I. Approval of Spring Notes

A. amend IX (amount donated to The Archaeology Channel) from \$500 to \$250 (motioned and approved)

#### II. Approval of Treasurer Notes

A. motion to allow the President and the Treasurer to discuss investment options via email due to market volatility (approved).

#### III. Subcommittee Reports

A. Membership: The issue of membership dues payment being lost was discussed. Multiple checks must be written at conference and those checks go to different places. It was proposed that a single check be sufficient for membership/meeting dues and the President will discuss with Treasurer.

#### B. Publications:

i. 100 contexts will be reprinted and a 60/40 split between CCPA and CAS; Jason LaBelle brought split to CAS and was agreed and CAS asked about searchable pdf.

ii. It was noted that the original manuscripts are gone and there is a formatting issue. It was also determined that creating a searchable pdf may be prohibitively time consuming.

iii. Contexts to be reprinted at this time include all but the Southwest Colorado context (n=400 @ \$11,000 – 12,000).

iv. Context revisions: reviewed and discussed. Agreed to follow-up similar to what was agreed at spring meeting – Christy Smith to explore SHF funding grant. Opportunity for revisions to be given to first author(s) of each context regardless of present employment status with original company that had the contract.

v. Various potential structures of future context updates were discussed. The format will most likely be CDs.

#### C. M. Martorano reported that no official complaints were received.

Lucy introduced CCPA/CAS schism and related that some CAS members prefer to merge organizations. The Secretary pointed out that merging the organizations based “on being left out” by CAS members is ridiculous despite the historic precedence of CAS and stated further that CCPA is a professional membership organization that should remain outside of avocational CAS.

D. Pinyon Canyon Subcommittee: Diane Rhodes submitted a spreadsheet/timeline of actions to date. It was discussed that ICI Services, who currently has the cultural resource contract, lacks regional qualifications. It was decided that a “reaffirmation” letter pertaining to consulting status be sent to the Army. Questions that were raised include importance of not losing consulting status; timing of affirmation letter, and the potential for a scientific coalition. CCPA issues will be presented during scoping.

IV. Newsletter: October 10 for updates. A last call was made for archival materials.

V. Website: No updates from Mary Sullivan. A notice will be announced when job listings have been filled.

## Old Business

VI. Ward Weakly: A motion was made to increase the fund to a maximum of \$1,000 pending a discussion with Adrienne Anderson. A limit will be made as to the number of awards.

VII. Crow Canyon Scholarship: CCPA was notified of scholarship amount increase. It was decided that the amount of the scholarship from CCPA will be decided on a yearly basis.

VIII. The Archaeology Channel: Lucy paid a CCPA donation of \$250 in person.

IX. CAS Collaboration: President has attended recent meetings. A discussion ensued around including CAS meetings with CCPA annual meeting. A panel discussion around archaeological topics including lithic sourcing, rock art, ceramics, wickiups (DARG), and projectile points.

X. Student Paper: Mark Mitchell's suggestions were adopted.

XI. Archival (S. Larmore): It was suggested that formal procedures for archiving at the end of a Secretary's term be implemented; adopt Bridget Ambler's archival procedures; Sean will go through archival submission list, compare for duplication, and request collections from individuals.

XII. 2009 Officers: A call for potential candidates. Several names were suggested for executive committee members and officers slate.

XIII. 2009 CCPA Meeting: dates were changed to April 3-5. A potential location of Montrose hosted by Alpine Archaeological Consultants was briefly discussed for 2010.

## **New Procedures for Inadvertent Discoveries on State And Private Lands.**

On December 2, 2008 the Colorado Historical Society (CHS) and the Colorado Commission of Indian Affairs (CCIA) received written authorization from the Department of the Interior to proceed with the implementation of the *Process for Consultation, Transfer and Reburial of Culturally Unidentifiable Native American Human Remains and Funerary Objects Originating From Inadvertent Discoveries on Colorado State and Private Lands (Process)*. The creation of the *Process* began in 2005, when CHS, CCIA, the Ute Mountain Ute Tribe and the Southern Ute Indian Tribe partnered on a National Park Service grant to consult with 45 additional tribes with ancestral ties to the lands of Colorado. As a result of consultations, the *Process* was written, emphasizing three points of agreement voiced by tribes in 2006:

- in situ preservation of individuals
- nondestructive analysis of remains
- authorization of the two Ute tribes in Colorado to take the lead on reburials of culturally unidentifiable Native American human remains and associated funerary objects should no other tribe come forward.

The *Process* works within the Native American Graves Protection and Repatriation Act (NAGPRA) as well as Colorado State Burial Law. The *Process* provides for respectful and expedient disposition of culturally unidentifiable remains and funerary objects within 100 days of their inadvertent discovery. Colorado is the second state in the United States to develop such a process. The National NAGPRA Program has indicated that it may serve as a model for other states that are grappling with similar issues. ## **Twenty-Five Years Ago in Colorado Archaeology (Winter 1983-1984)**

- CCPA agreed to support the Colorado Archeological Society's (CAS) bid to host the 1986 Plains Conference in Denver and to assist CAS in that effort.
- In July 1983, Steve Cassells led over 30 CCPA participants in a field trip throughout the Gunnison Basin. Participants camped in Curecanti and visited NPS excavations underway at the park. Other sites visited included an Italian railroad camp, the Ute Fortified Site, Silver Plume Mine, jasper quarries at Cochetopa Park, and the Alpine Tunnel.
- Barbara Sudler was appointed Colorado SHPO, after acting for a number of months. She was to do the job in concert with her position as President of the Colorado Historical Society.
- Wrap-up to Colorado Archeological Awareness Year (CAAY) 1983 activities was underway. The CAAY oversight committee consisted of two members from CCPA, CAS, and CHS: Jim Hester, Bruce Rippeteau, Emerson Pearson, Linda Gregonis, Bill Tate and Frank Adkins. January 1983 had been proclaimed the state's first Archeological Awareness Month, which was followed by events around the state throughout the year – much as during the Current Archeology and Historic Preservation Month. The final report was put out January 1984 as a *Colorado Historical Society Newsletter*.

- Plans were made for CCPA's sixth annual meeting to be held at the University Memorial Building, University of Colorado, Boulder campus March 9-10, 1984. Activities proposed included a chili cook-off and limerick contest. And, a monetary prize was being offered for the best student paper.
- Near the end of 1983 issues first surfaced with the Pinyon Canyon Project (University of Denver under contract to the Interagency Archeological Services, National Park Service) that would ultimately consume much of CCPA's time during 1984.

**Native American Member:** Sponsorship by any member of any recognized tribal organization, government, or by the Colorado Commission of Indian Affairs. Annual voting membership fee is \$30.00.

**Associate:** BA or BS degree or enrollment in a degree program, sponsorship by 1 voting, charter or fellow member and a professional interest in Colorado archaeology. Annual associate membership fee is \$25.00. Include a copy of vita or resume with application.

**Student Voting:** Professional resume or vita listing 2 months professional experience, 3 professional references and a BA or BS degree in anthropology or a related discipline and proof of enrollment in a postgraduate degree program in anthropology or a related discipline. Upon completion of the postgraduate degree, the individual will become a Voting Member and will be required to pay the full dues for that status with the next annual renewal. Annual Student Voting membership fee is \$10.00.

**Student Associate:** Professional resume or vita with 1 professional reference and proof of enrollment in an undergraduate degree program in anthropology or a related discipline. Upon completion of the undergraduate degree, the member must reapply as either an Associate or Voting Member during annual renewal. Annual Student Associate membership fee is \$10.00.
