Minutes Colorado Council of Professional Archaeologist Executive Committee Meeting March 31, 2006

Attendees: Tom Car, Ted Hoefer, Minette Church, Marilyn Martorano, Chris Bevilacqua, Dulaney Barclay, Joel Tyberg, Lucy Bambrey, Lovella Learned-Kennedy, Bridget Ambler, O.D. Hand, and Mary Sullivan.

- A proposition was presented to create a CCPA Membership Director to coordinate a new membership drive. Jon Horn was volunteered for this position. The Treasurer would keep the formal membership list. The Membership Director will be invited to executive committee meetings as a non-voting member.

- The time and place of the summer 2006 CCPA Executive Committee Meeting was discussed. I'll dispense with the details of this discussion since we all know we are meeting in downtown Denver at Il Vicino, 550 Broadway, on Thursday, June 15th, at 7pm.

- The idea of including a Native American liason CCPA member was discussed. The following individuals were mentioned as options: Terry Knight, Becky Hammond, and Linda Baker. It was agreed that Terry Knight would be the first to be invited to participate. (Mr. Knight has subsequently agreed to serve in this capacity).

- The need for CCPA representation at the El Pueblo Museum Archaeology Pavilion dedication was discussed. Ted, Minnette, and Marilyn indicated they would be attending. It was suggested that Barb send an e-mail to members to remind them of the event. - Minette, Kelly, and John Scott were scheduled to represent CCPA at the Council of Councils at the SAA meetings in San Juan.

- Standing membership on Committees was discussed

Ted is to replace Adrienne on the Ward Weekly committee

Joel and John will be on the Membership committee - Marilyn is to be replaced

- Colorado Preservation Inc. Public Policy Committee. CCPA has maintained a presence at these meetings. Ted, Bridget, Tom, and Joel are available to attend. The committee meets every two weeks during the legislative session. Details to be announced.

- Native American Scholarship discussed. - It was suggested that CCPA write a letter to Crow Canyon to prompt them to make a larger effort to administer the Native American scholarship program. What are they doing and how can we help? - It was brought up that we should put a disclaimer at the top of our membership that states "not for dissemination".

- It appears that the newsletter in getting bounced back from many members e-mail addresses. We need to start collecting two email addresses per member.

- The question was raised as to whether CCPA will grant CAS permission to produce and sell Colorado Archaeology. Apparently I made a motion for CCPA and CAS to split the production costs and profits 50/50. It was seconded by Dulaney. The motion passed. Also, would there be an option to let CAS reproduce and sell Colorado Archaeology on its own? The consensus was yes, but again 50/50 split.

- Adrienne raised a question about how to return funds to the Ward Weekly fund.

It was generally agreed that the student paper award would now be open to non-Colorado projects and students.

Treasurer's Report – Dulaney Barclay

The CCPA account balances are as follows: \$703.07 in Checking account; \$13,703.95 in Money Market account; \$5,088.79 in Publications account; \$8,516.61 in Ward Weekly account; \$38, 394.44 in the Historic Context Grant account. Income since January 1, 2006 is as follows: \$5,823.50 from the Annual Conference; \$3,360.00 from Membership dues; \$1961.29 from sales of Ancient Colorado (\$286.17) and Prehistoric Contexts (\$1675.12). Expenses since January 1, 2006 are as follows: \$3,360.67 for the Annual Conference; \$6,244.71 for the Historic Context; \$250.00 for contribution to The Archaeology Channel; \$967.62 for Office Supplies (new computer, file folders, CDs), \$108.24 for printing & reproduction; \$575.00 for Professional Fees (CCPA fee for 2005 tax return); \$156.42 for Summer Board Meeting in Denver; \$24.36 for Postage;\$4,049.64 for Miscellaneous expenses (\$500.00 for Preservation Month Poster, \$2,989.84 for publication of *Colorado Archaeology*; \$500.00 for Ward Weekly Scholarship, \$50.00 for Website listing, \$10.00 fee for change of Registered Agent with Colorado Secretary of State).

There are five stratified layers within the pit, dating from BMII through late BMIII or Early PI. Reynolds is investigating the change in the faunal assemblage as the population transitioned from a hunting to a more agrarian society.

WHAT: Archaeological Assessment and Test Excavation of Site 5SH2373, Arroyo del Arenal

WHERE: Great Sand Dunes National Park

WHEN: September 8, 9, and 10, 2006

PROJECT DESCRIPTION: ERO Resources, RMS Consultants, and the National Park Service, in conjunction with the Friends of the Dunes, are seeking experienced volunteers to in the fieldwork portion of a Colorado Historical Society grant. Fieldwork will consist of survey, instrument mapping, in situ artifact analysis, and limited test excavations. Arroyo del Arenal is a very significant site discovered in 2004 that produced Tewa and probably Apachean ceramic sherds, along with a diverse artifact assemblage, and known subsurface cultural deposits. Accommodations will be camping with limited vehicle access. NPS per diem will be provided (\$15/day). Volunteers must commit to a least two of the days. Excavation experience is preferable and PAAC certification in survey techniques mandatory.

JUST FOR FUN

Twenty Five Years Ago in Colorado Archaeology

1981 – Summer

- Production of CCPA's Newsletter moved from the Colorado Preservation Office to Colorado State University. Cal Jennings became Editor with Liz Morris, Joyce Herold, and Earl Ingmanson serving as the editorial board. This board instituted a series of new features and procedures, some of which continue today, such as a column in each issue written by CCPA's.
- The fall meeting of the Executive Committee was held in October in conjunction with the Anasazi Symposium at Mesa Verde National Park.

- CCPA's Standing Committees were: Nominations, Membership, Ethics, Legislative/Permitting, and the Newsletter.
- CCPA's Special Committees were: Bylaws, Legislative Funding, Research Design, and Logo.
- An *ad hoc* committee headed by Judi Halasi researched the matter of how much lobbying CCPA can engage in without jeopardizing its tax exempt status. CCPA can pursue direct contacts with legislators and other officials in so far as it does not engage in "grass roots" lobbying. That is, if all correspondence is directed to elected or other officials and no attempt is made to include members of the general public.
