- Ability to qualify at a supervisory level for the state (WY, CO, ND, MT) and federal archaeological permits.
- Knowledge and experience in the High Plains and Great Basin prehistory and/or history archaeological method and theory, and applicable federal, state laws, as well as local regulations and compliance requirements.
